Stipulation and Order

STIPULATION

NOW COME the parties, by and through their respective counsel, and hereby stipulate to the following in resolution of the pending action before the Court:

1. **Agreement to enter child custody order:** The parties agree that a child custody order shall be entered in both Brazil and Michigan concurrently modifying the Cuban orders regarding the minor child with terms effectuating the following agreement of the parties:
 - a. Effective December 27, 2024, that the minor child will primarily live with the Petitioner/Mother during the minor child's school year and with the Respondent/Father during the school breaks.
 - b. That the Respondent/Father will have visitation with the minor child ^{during the} Brazilian equivalent of Summer break, Winter break, and Spring Break.
 - c. That, unless otherwise mutually agreed upon, the parties will split the transportation for parenting exchanges with the party beginning his/her time being responsible for facilitating the child's transportation to begin his/her time.

- d. That the parties will permit the minor child to have daily communications with the other parent via WhatsApp.
- e. That the minor child will begin school in Michigan and remain with the Respondent/Father until December 27, 2024. That the minor child will complete the remainder of his 1st semester of school virtually while he is Brazil.
- f. Both parties shall make the minor child available to the other parent to be able exercise parenting time with the minor child while the other parent is visiting in the country. This includes, but is not limited to, while the Petitioner/Mother is currently in Michigan until Aug 30, 2024.
- g. That both parties agree that the minor child shall be permitted to continue to play Soccer once he is in Brazil.

2. Passport:

- a. Both parties shall sign the paperwork required for the minor child to obtain a US passport and a Brazilian passport.

3. Citizenship:

- a. The parties agree to work towards the minor child obtaining both United States Citizenship and Brazilian citizenship.
- b. The Petitioner/Mother shall sign all required paperwork required for the minor child to obtain United States citizenship and the Respondent/Father shall sign all required paperwork required for the minor child to obtain Brazilian citizenship. Both parties shall comply with any requirements required by each country as part of that process.

4. Attorney Fees and Costs:

a. Both parties shall be solely responsible for his/her own attorney fees and costs in this matter.

5. Continuing Jurisdiction:

a. That this court retains continuing jurisdiction to be able to enforce the terms contained herein until such time that the parties file a joint stipulation dismissing this matter.

ORDER

IT IS HEREBY ORDERED that the above stipulation is approved and adopted as an Order of this Court.

IT IS SO ORDERED.





